# BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)(CIVIL ENFORCEMENT) ORDER 2013 AMENDMENT NO.19 2022

**NOTICE IS HEREBY GIVEN** that the Bridgend County Borough Council (hereinafter referred to as "the Council") as the Highway Authority for Bridgend have made an Order in exercise of their powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49,51,53,124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which is to:-

- 1. Amend the Bridgend County Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places)(Civil Enforcement) Order 2013 ("the 2013 Order) by the revocation of the Order Plans BS29 Revision 2 and BT29 Revision 1 and the insertion of the revised Order Plans BS29 Revision 3 and BT29 Revision 2.
- 2. Designate Residents Only Permit Holders Parking Places under section 45 of the Road Traffic Regulation Act 1984 as set out in **schedule 1**;
- Introduce Limited Waiting 8am-8pm– 2 hours maximum stay -no return within 4 hours OR Residents Permit Parking Places 8AM-8PM (Shared Use Bay) restriction set out in schedule 2 below. The Residents Permit Parking Places 8AM-8PM are designated under 45 of the Road Traffic Regulation Act 1984 and
- 4. Introduce a Prohibition of Waiting At Any Time restriction as set out in **schedule 3** below.
- 5. Revoke Schedule 1 to the 2013 Order and substitute the contents of schedule 4 below.

The charges for residents' permits are, for the purpose of section 46 of the Road Traffic Regulation Act 1984, those prescribed by Schedule 4 below and are incorporated into Schedule 1 to the 2013 Order.

The order was made on the 29/07/2022 and will come into force on the 12/08/2022.

If any person wishes to question the validity of any Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks from the date on which the Order is made, apply for the purpose to the High Court.

## SCHEDULE 1 (DESIGNATE RESIDENTS PERMIT PARKING PLACES)

## Suffolk Street, Bridgend

(i) On the southern side of the carriageway from a point 10m (11 yards) east of the western kerb line of Cheltenham Terrace for a distance of 56.5m (62 yards) in an easterly direction.

#### Jenkin Street, Bridgend

(i) On the western side from the boundary of 2/4, Jenkin Street, for a distance of approximately 97 meters (106 yards) in a southerly direction.

(ii) On the eastern side from the boundary of 1/3, Jenkin Street, for a distance of approximately 73 meters (80 yards) in a southerly direction.

(iii) On the eastern side from a point 79 meters (86 yards) south of the boundary of 1/3 Jenkin Street for a distance of approximately 13 meters (14 yards) in a southerly direction.

## South Place, Bridgend

(i) On the western side of the carriageway, from a point 5 meters (5 yards) south of the southern kerb line of Suffolk Street for a distance of approximately 24 meters (26 yards) in a southerly direction.

## Cheltenham Terrace, Bridgend

(i) On the western side from a point 12 meters (11 yards) south of the southern kerb line of Free School Court for a distance of approximately 105 meters (115 yards) in a southerly direction.

(ii) On the eastern side from a point 8 meters (11 yards) south of the southern kerb line of Free School Court for a distance of approximately 94 meters (103 yards) in a southerly direction.

## <u>SCHEDULE 2</u> (LIMITED WAITING 8AM-8PM – 2 HOURS MAXIMUM STAY -NO RETURN WITHIN 4 HOURS) <u>OR</u> (RESIDENTS PERMIT PARKING PLACES 8AM-8PM) (SHARED USE BAY)

# Free School Court, Bridgend

(i) On the northern side from a point 35 meters (38 yards) east of northern kerb line of Nolton Street for a distance of approximately 40 meters (44 yards) in an easterly direction.
(ii) On the Nothern side from a point 75 meters (83 yards) east of the northern kerb line of Nolton Street for a distance of approximately 82 meters (90 yards) in an easterly direction.

#### SCHEDULE 3 (PROHIBITION OF WAITING AT ANY TIME)

# Free School Court, Bridgend

(i) On the southern side at its eastern termination point for a distance of approximately 4 meters (4 yards) in a westerly direction.

(ii) On the northern side, at its eastern termination point for a distance of approximately 6 meters (7 yards) in a southerly direction.

(iii) On the northern side at its termination point for a distance of approximately 4 meters (4 yards) in a westerly direction.

## Cheltenham Terrace, Bridgend

(i) On the eastern side from the northern kerb line of Suffolk Street for a distance of approximately 4 meters (4 yards) in a northerly direction.

## Suffolk Street, Bridgend

(i) On the northern side from the eastern kerb line of Cheltenham Terrace for a distance of approximately 4 meters (4 yards) in a easterly direction.

(ii) On the northern side from a point 27 meters (30 yards) east of the eastern kerb line of Cheltenham Terrace for a distance of approximately 10 meters (11 yards) in an easterly direction.

(iii) On the northern side from the western kerb line of Jenkins Street for a distance of approximately 5 meters (5 yards) in a westerly direction.

(iv) On the southern side from the western kerb line of Cheltenham Terrace for a distance of approximately 10m (11 yards) in an easterly direction.

(v) On the southern side from the western kerb line of Jenkins Street for a distance of approximately 5 meters (5 yards) in a westerly direction.

#### Jenkin Street, Bridgend

(i) On the western side from the northern kerb line of Suffolk Street for a distance of approximately 5 meters (5 yards) in a northerly direction.

## South Place, Bridgend

(i) On the western side from the southern kerb line of Suffolk Street for a distance of approximately 5 meters (5 yards) in a southerly direction.

(ii) On the western side of the carriageway, from a point 29 meters (32 yards) south of the southern kerb line of Suffolk Street for a distance of approximately 5 meters (5 yards) in a southerly direction.
