Dear Susan, Nick and Nicola,

We have received an enquiry from Redrow Homes, South Wales regarding a potential residential site at Coychurch Road, Pencoed.(Site Plan enclosed).

A meeting was held earlier today (Tuesday 5 February 2013) to discuss the proposals and establish our views upon the potential flood risk associated with the site.

Those present were;

Jose Ferreira ; Ben Porte and Andrew Morgan - Redrow Homes.

Tim O'Brian – Mott MacDonald.

Barry Cox and myself - Environment Agency Wales.

Jose and Ben explained the background to their interest in the site and how it related to the context of the ongoing Bridgend LDP examination process. We understand that the Inspector Mr Mellor has requested the Council to seek additional/alternative parcels of land potentially suitable for development to meet the County's prospective housing/employment requirements. We have infact responded earlier this week to Nicola on other sites which are of interest to your authority.

In the context of the Coychurch Road site we offer the following generalised comments;

No development within the C2 Flood zone of the site, as defined by the development advice map referred to under TAN 15 Development and Flood Risk (July 2004), shall take place unless the production of a Flood Consequence Assessment demonstrates that the consequences of flooding can be managed over the lifetime of the development and in accordance with the requirements of TAN 15.

I hope this assists you and the Inspector in your determination of the alternative sites.
