Rhoddir hysbysiad gan hynny fod Cyngor Bwrdeistref Sirol Pen-y-bont ar Ogwr yn arfer ei bwerau o dan Adranau 1(1), 2(1) i (3), 4, 25, 32, 35, 36, 45, 46, 46A, 47, 49, 51, 52 a 53 a 124(1) a Rhan IV o Atodlen 9 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (Deddf 1984) fel y'i diwygiwyd a Gorchymyn Dynodi Gorfodi Sifil ar Dramgyddau Parcio (Bwrdeistref Sirol Pen-y-bont ar Ogwr) 2013 a rheoliad 21 o Ran IV o Reoliadau Gorchymynion Traffig Awdurdodau Lleol (Gweithdrefn)(Cymru a Lloegr) 1996, a'r holl bwerau galluogi eraill, ac ar ôl ymgynghori â Phrif Swyddog yr Heddlu ac yn unol â Rhan III o Atodlen 9 i Ddeddf 1984, sydd wedi gwneud y Gorchymyn uchod ("y Gorchymyn Cydgrynhoi") a fydd yn cael effaith a ganlyn:-

(i) Dirymu a disodli, heb unrhyw newidiadau i'r cynnwys, gorchymynion parcio ar y stryd blaenorol fel y nodir yn Erthygl 64 yn y Gorchymyn hwn i'r graddau y maent yn effeithio ar gyfyngiad a chaniatâd parcio ar y dyddiad y daw'r Gorchymyn Cydgrynhoi i rym ar draws holl ardal weinyddol Cyngor Bwrdeistref Sirol Pen-y-bont ar Ogwr.

(ii) Bydd y Gorchymyn Cydgrynhoi yn gwneud yr holl gyfyngiadau parcio ac aros yng Nghyngor Bwrdeistref Sirol Pen-y-bont ar Ogwr fel y'u rhestrir yn atodlen 2 "mynegai y cynllun" ac fel y'u dangosir ar y Cynlluniau yn Atodlen 1 i'r gorchymyn hwn yn ddarostyngedig i ddarpariaethau y Gorchymyn Cydgrynhoi.

Gwnaed y Gorchymyn Cydgrynhoi ar 19 Tachwedd 2024 a bydd yn dod i rym ar **29 Tachwedd 2024**.

**NOTICE OF MAKING OF CONSOLIDATION ORDER**

**BRIDGEND COUNTY BOROUGH COUNCIL**

**(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024**

Notice is hereby given that Bridgend County Borough Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 25, 32, 35, 36, 45, 46, 46A, 47, 49, 51, 52 and 53 and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and The Civil Enforcement of Parking Contraventions (County Borough of Bridgend) Designation Order 2013 and regulation 21 of Part IV of the Local Authorities' Traffic Orders (Procedure)(England and Wales) Regulations 1996, and of all other enabling powers, and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 to the Act of 1984, has made the above Order ("the Consolidation Order") which will have the effect of:-

(i) Revoking and replacing, without any changes to content, previous on street parking orders as stated in Article 64 in this Order as far as they affect restriction of and permission for parking on the date that the Consolidation Order comes into effect across the whole of the Bridgend County Borough Council administrative area.

(ii) The Consolidation Order will make all parking and waiting restrictions within Bridgend County Borough Council as listed in schedule 2 "plan index" and as shown on the Plans in Schedule 1 to this order subject to the provisions of the Consolidation Order.

The Consolidation Order was made on 19th November 2024 and will come into force on **29th November 2024**.

If any person wishes to question the validity of the Consolidation Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act or that any requirement or an instrument made under the 1984 Act has not been complied with that person may do so by application to the High Court within 6 weeks from the date the Consolidation Order was made.
